4. Description of your research activities (max 10 lines)*

Oil and Gas (O&G) contracts contain provisions to protect the environment and to develop domestic economies (local content), especially in developing countries. Local content provisions and environmental clauses may contribute to reduce greenhouse gas emissions and to develop energy and climate technology even across the O&G value chain, since those clauses or provisions may be mandatory not only to all the parties of the O&G contract but also to the contractual network required to perform O&G activities. Therefore, the objectives of the research are: (i) Comparative analysis between Latin American O&G contracts and the predominant European O&G contracts (license); (ii) Analysis of local content provisions and environmental clauses in both European and Latin America O&G contracts; and, (iii) Study of the corrective measures and other remedies, as well as the decision-making process in O&G contracts, in order to determine the contractual governance of O&G contracts and how the cooperative approach that is typical of multiparty contracts and contractual networks defines O&G contracts.
